1. Digital Boundaries Product

A digital version of the Tailte Éireann (TÉ) Registration Title Plan product, together with relevant Folio details, is available on request. The Digital Boundaries product consists of the registered geometry of the parcel(s) within a Folio in CAD format and projected in ITM, together with the geometry of relevant burdens, if requested at time of application. The TÉ Surveying vector geometry is not supplied. While the Folio is not included, a CSV file is provided which contains the following details: Folio number, property number, plan number, seedpoint ID, registered owner(s) name and address, and pending applications. This transaction type is processed under Item 28 of the Land Registration Fees Order 2012 as **"Other Service"**.

2. General Data Protection Regulation (EU) 2016/679

In accordance with GDPR guidelines, this service is limited to a maximum of <u>three</u> Folios. Should the requestor require more than <u>three</u> Folios the following options should be considered:

• Continue with the request to include more than three Folios but forego the inclusion of the associated Folio details as part of the delivery.

<u>OR</u>

• Where the Folio details are required, request that the job be processed under Item 22 of the Land Registration Fees Order 2012 "*Provision of electronic extract from the Registry map within the limits set by TÉ*" (see Registration Mapping Guide 7(b)). Customers should note that all jobs processed under Item 22 of the Land Registration Fees Order 2012 will require the requestor to sign a protocol agreement.

3. Fee information

Jobs processed under Item 28 of the Land Registration Fees Order 2012 command a fee of €40 per Folio included in the output. (see Table 1)

• Jobs processed under Item 22 of the Land Registration Fees Order 2012 command a fee of €120 plus €5 per folio included in the output. (see Table 2)

4. How to apply

Applications for digital boundaries for up to three Folios, or for more than three folios where the Folio details are not required, should be made to the TÉ Registration Spatial Information Unit (SIU) in Waterford at <u>spatialquery@tailte.ie</u>. The following information is required:

- Folio number(s) required
- Contact details
- Confirmation of payment method (if payment is through Landdirect account number should be quoted; if payment is by credit card contact number required).

For applications involving more than three Folios where the Folio ownership details are required, contact the TÉ Registration Bulk Data Unit at registrationbulkdata@tailte.ie.

Once payment has been received, the data will be delivered via Cisco Secure e-mail service. Customers are required to have a Cisco e-mail account.




Figure 1 Digital Boundary Template
